General Information

Target Audience

This course is designed for practicing clinical radiologists in academics or private practice.

Statement of Need

General radiologists must be aware of the changes and developments in all areas of radiology imaging (MR, CT, US) including Thoracic, Pediatric, Abdominal, Musculoskeletal, Neuroradiology and Cardiac Imaging in order to maintain certification and maximize patient care. It is imperative that radiologists stay up-to-date on the latest imaging protocols. Radiologists should be equipped to assess responses to minimally invasive interventional radiology treatments and recognize the complications and they should understand the risks of intravenous contrast and safety issues related to radiation doses and minimizing exposure to patients.

Course Description

This course is intended to provide an overview and update of current state-of-the-art imaging techniques (MR, CT, US). The program will address appropriate protocols that can be applied to a variety of practical clinical situations. Lectures will emphasize image interpretation, differential diagnosis, pitfalls and review the pathophysiologic basis for imaging findings. Topics covered will include: Abdominal Imaging, Cardiac, Neuroradiology, Thoracic, Musculoskeletal and Interventional Radiology.

- Address common patient safety issues such as radiation dose reduction, the risks of intravenous contrast, and administration of pre-exam medications.
- Implement advanced imaging protocols (including body, thoracic, musculoskeletal, cardiac and neuroradiology) for state-of-the-art imaging equipment in order to enhance imaging findings and avoid common pitfalls.

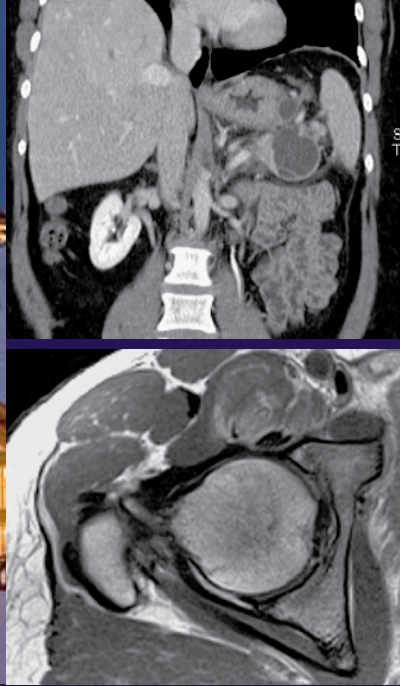
