Overview and Target Audience

The use of such an approach in turn allows the radiologist to generate a coherent and articulate report. While basic anatomy and common patterns of disease are reviewed, the emphasis of this workshop is on providing the practitioner with an organized approach to the interpretation and reporting of head & neck scans, which can then be incorporated into their daily practice.





Objectives and Outcome:

After completing this workshop, the participant can expect

- 1. an improved understanding of basic anatomy and common pathology in the head & neck.
- 2. an organized and reproducible system for interpreting head & neck scans.
- 3. a well-defined framework for the reporting of these scans.
- 4. an increased level of confidence in approaching head & neck imaging studies.
