Target Audience

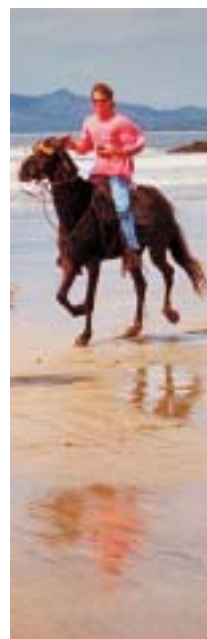

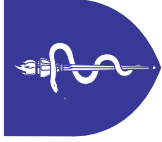
